### **INTRODUCTION**

## UNDERSTANDING COOKIES

Cookies are small text files stored on your device (computer, smartphone, or tablet) when you access our website. They contain information that helps us recognize your device during future visits, improve performance, and deliver a more personalized experience.

Cookies can be set either by our site (first-party cookies) or by third-party services used on our platform (third-party cookies). They generally fall into two categories:

- **Session Cookies:** These are temporary and expire once you close your browser.
- **Persistent Cookies:** These remain on your device until manually deleted or they reach their expiry date.

## YOUR CHOICES AND CONTROL

You are not obligated to accept cookies when using our services. You have full control over your cookie preferences and can modify your browser settings to block or delete cookies.

However, disabling certain cookies may affect your ability to access features such as secure login, transaction functionality, and customized user settings. We encourage you to allow essential and functional cookies to ensure the best user experience on the SoCrazy platform. For details on managing cookies, refer to your browser's help documentation.

## TYPES OF COOKIES WE USE

### 1. Essential Cookies

These cookies are strictly necessary for our website and crypto services to function. They enable features such as secure account access, transaction validation, and site navigation. Without these cookies, key operations related to \$CRAZY may be disrupted. They do not collect personal information for marketing.



## 2. Functional Cookies

Functional cookies help remember your preferences, such as language settings or wallet options. They enable a more tailored and user-friendly experience. These cookies may persist between sessions and are usually anonymized.

## 3. Performance & Analytics Cookies

These cookies collect aggregate data about how visitors use our website. Metrics such as page views, session duration, and error logs help us identify areas of improvement for SoCrazy. The information is anonymized and used exclusively for internal performance optimization. We may use third-party tools like Google Analytics or similar services to analyze this data.

## 4. Advertising & Targeting Cookies

These cookies track your activity across websites and may be used to show you relevant ads or content based on your interests. They help limit repetitive advertising and improve campaign effectiveness. In some cases, we may collaborate with trusted advertising partners who set these cookies on our behalf. All such use is in accordance with applicable data protection laws.
